

EVENTS DURING 1-1-2006 AND ONWARDS :

Gold Jewellery India International Exhibition was held in Chennai from 16th of February 2006 to 18th of February 2006. These 3 day business to business event marked the presence of top jewellery manufacturers all over India and also some foreign exhibitors, jewellery making machinery and other products, ancillary industrial units like alloys manufacturers, packaging materials, display items and a wide array of jewellery associated products, including Silver Jewellery. This exhibition has elicited lot of interest to the business, from Bangalore more than fifty members have participated and visited the show.

A felicitation meeting was held by the Arya Vysya Mahasabha at the Vysya Hostel in Seshadri Road to Sri D. Shankara Murthy on his being inducted into the state cabinet as a minister. Presently Sri D. Shankara Murthy is the education minister in the state cabinet. The association was represented by the vice-president sri B.K. Manjunath and one of our directors Sri B.M. Sunil. A momento & a shawl were presented to the minister.

A visit to the Panna Mines was arranged by Sri Suresh I. Dhruv our director. Ten of our directors visited the mining site. It was a highly educative tour.

A Jewellery Tech Park project has been proposed for Bangalore Large Scale Industries Minister sri Katta Subramanya Naidu convened a meeting at Vidhana Soudha highlighting the project and participation by the Jewellers' Association would be ideal for the project as it would benefit the state and the trade and the artisans. The Gem & Jewellery export promotion council has welcomed the proposal. Our hon. secretary sri P.V. Mahesh and director sri Ramesh of Davanam Jewellers are assisting and advocating for this proposal. Sri P.R. Srinath and sri Shankar of Garla Narayana Setty Jewellers were special invitees to the interactive meeting.

The all India International Jewellery Show 2006 was held in Bombay from 4-5-2006. This was an excellent show arranged along with the GJEPC Bombay (the 4 day event) had attracted a very large number of participants from all over India & abroad. More than 200 members of our trade attended this annual event. The art of Jewellery, Bangalore's own magazine were the official magazine for the event. Mr. Sumesh Wadhera the publisher of the magazine has been adding feathers to his cap; an ardent supporter and admirer of the Jewellers' Association, Bangalore.

As a part of Gold Jewellery sales promotion a "Gold Festival" was arranged in Bangalore by the Association, along with the Art of Jewellery Magazine as co-sponsor. It is needless to say that the World Gold Council has been very active and supportive to the trade under the able stewardship of sri Shivram, now the senior vice-president of WGC. This was an all Karnataka Event. This event was for around 40 days from 4-4-2006 to 25-5-2006.

A "Goldonomics" Seminar was held at Shivaratreeshwara Hall, Jayanagar, Bangalore, to get more knowledge on the "Economics" of Gold the "Versatile precious Metal". With the "Volatile Rates" ruling the market, it was the brain child of our president to know the full circle of Gold Trade from experts. He kept on telling the committee members to scout out and arrange an appropriate interactive seminar/meeting with Gold analysts/experts. In fact, our president himself admits that he was pestering his colleagues to an irritable level for arranging such an event. Finally that D-day arrived on 28-5-2006. The seminar was attended by a large number of our members and some who were not in this trade. The speakers on the subject were Sri Bhargav Vaidya, Gold Analyst & Advisor to merchant banks on Gold related matters. His knowledge of the market is so wide his suggestions carry great value. Mr. Rajan Venkatesh head of Gold marketing Bank of Nova Scotia Mocatta also gave an interesting statistics in the present scenario. While the seminar enlightened the members the basic questions and problems of the volatile rates which is affecting the gold jewellery traders could not be understood by the trade. The trade is still feeling this rate fluctuations is only because of the on-line trading. The trade feels a modification by MCX and other agencies to increase the margin money to be deposited be hiked to 50% on the total value of the contract. May be then, this wild fluctuations will cease and the jewellers can have peace and confidence in their business. The trade has to represent this matter to the concerned authorities, in central government level. What is happening now is total gambling which is certainly not congenial to the Gold & Silver Jewellery Trade.

The world's biggest jewellery trade promotion at all India level was mooted at Bangalore on 11-7-2006 at Bangalore, the organisers being the Gold Jewellery Federation, the World Gold Council and the Jewellery Associations all over India. This "Lucky Lakshmi Festival" the first in India involving participation of more than 1500 jewellers from all over India. Bangalore accounted for 150 members, and from other parts of Karnataka over 100 members. This big festival was a success as it evolved good response. The whole idea is to make the consumers invest on Gold Jewellery rather than spending their money on other luxury consummables. The all India Gold Jewellery Federation, brought both the G.J.E.P.C. & the D.T.C.

on one platform. The WGC rightly encouraged and sponsored the big event. The art of jewellery was the official magazine. This event was during the period from 23-9-2006 to 11-11-2006. In my personal capacity as the Hon. Secretary and on behalf of our president Sri D.A. Sreeramulu and all the office bearers our managing committee I thank them all. In this connection my colleague Sri S. Venkatesh babu, the Hon. Treasurer & Vivek B. Chand visited hubli for promotion to participate in the festival. Sri G.R. Chetan & Sri Prathap Kamat both director's visited mysore.

On 5-9-2006 ING Vysya Bank arranged a meeting with the Jewellery trade at their M.G.Road premises. Senior officers and their executives presented their business promotional ventures and have offered a number of packages for jewelers to expand their business. I would like to mention here the bank has been extending financial and other facilities for jewellery exporters for more than 15 years. On behalf of the Association I extend my heartfelt thanks. Those jewellers who want to avail this facility may approach the bank with reference from the Jewellers Association.

HALL MARKING

The Bureau of Indian Standards had arranged an awareness programme on Hall marking of Gold and Silver Jewellery/Arte facts on the 10th September, 2006 at the capitol, Raj Bhavan Road, Bangalore-1. Senior officers of the BIS along Mrs. Alka Sirohi additional secretary ministry for consumer affairs, Govt. of India New Delhi. Mrs. Parmindar Bajaj gave the details and the purpose of the meeting. BIS Team was headed by Sri Y.P.Singh, chief of B.I.S., Mr. Sen Gupta, Director, Southern region, Mr. A.K.Talwar gave a detailed information of Hall Marking. Mr. Pillai of All India Jewellers Forum New Delhi was also on the dais. Mr. Mathews of BIS Bangalore co-ordinated the programme. On behalf of Bangalore, and the Jewellers Association, our President Sri D.A.Sreeramulu participated in the programme. A brief question and answer session was there. The Awareness Programme was attends by a large number of members of the trade. Lot of questions were there to be clarified. In this available time a majority of them were clarified & answered. After this meeting the Association has submitted a memorandum to BIS for certain clarification and some simplification of the formalities in registering for Hall Marking. As the deadline for registration, 31-12-2007 is fast approaching, it is advised that the members get registered early to avoid last minute rush.

RATE WARS / TRADE ALERT

A new phenomenon has cropped up in the Gold Jewellery Trade in Bangalore due to some of the Jewellers announcing heavy discounts in gold rates. The

marketing is very aggressive which is affecting the trade adding to the confusion arising out of heavy fluctuations in the rates. Our margins are now wafer thin and further discounts cannot be given to the customers. This kind of unhealthy strategy is making big dents to all the jewelers. This imported culture from a neighboring state is not necessary for Bangalore. As the slogans and advertisements were on a New high the association had to issue a "Trade Alert" to all the members and non members to refrain and restrict this new kind of marketing tactics as this would ruin the trade. Customers confidence level has taken a beating which is not congenial to the trade, both in short term and long term. On behalf of trade the present committee felt the necessity to issue the said Trade Alert on 25-8-06. From and on behalf of the entire trade all our committee members, we appeal to all those trade fraternity not to continue this insalubrious practice.

The annual "Jewels of India" exhibition was held at the Kanteerava Indoor Stadium from 30-9-2006 to 3-10-2007 in Bangalore. This event co-sponsored by the J.A.B., was well participated; over 100 Jewellers from Bangalore and all over India. An estimated 50,000 people have visited the exhibition.

Formation of Jewellers Association Bangalore Charitable Trust.

It is proposed to form a charitable trust as above: A sub committee is formed and the necessary modalities are to be formulated. This subject was brought to the notice in the previous general body meeting. The sub committee had a few meetings to finalize all the required modalities.

You are all aware of SMS that are being sent to all members quoting the rates of gold & silver once in every four hours. We are equipped to send any emergency SMS to all the members as and when required.

I am here with bringing to the notice of all the members, that our own premises has been leased out on a rent of Rs.25,000-00 1 shop and Rs.15,000-00 (another shop) to two different tenants presently a monthly rent of Rs. 40,000-00 (forty thousand) from 2 shops is being realized by the Association, as monthly rent. An advance of Rs. 11,00,000-00 (Eleven Lakhs) only has been received in this regard repayable to the lessee without interest after the termination of the lease. The said advance has been invested in nationalized banks as per bye-Law. Our vice-president Sri B.K. Manjunatha has been instrumental in finalising all the rental & advance agreements. I thank him profusely on behalf of the committee.

Assaying by the association is being done in an efficient way and it is requested that all the members send their samples to the association.
