



5. Any Member who wants to send any subject for discussion at the Annual General Body Meeting should send the same in writing to the Manager on or before **08-12-2023** under acknowledgement and are not permitted under any circumstances beyond this date.
6. Any Member's representative already registered with the Association, who wishes to contest the Election for the Managing Committee, is requested to send the nomination paper, only in the official form, duly signed, proposed and seconded by such Members, who are Mahaposhaks, Poshaks or Life Members of our Association.

# The Year that was...2023-24

**Jnana Jyothi:** The year started with a revision seminar was conducted on HUID and also Police issues at FKCCI auditorium. It was a well attended seminar.

**Wholesale Meeting:** The committee met and discussed on how to make Bangalore the B2B destination for jewellery. One of the options was to make our market synonymous with certain types of jewellery, and it was decided to promote our market as a hub of Nakshi and close setting jewellery. In order to achieve this there was a film made along with photo-shoot which was changed appropriately for SJS and also other events. It was also decided to have an in-store B2B shopping festival on the lines similar to the festival in Zaveri Bazar.

**Jewellers Badminton League (JBL 2.0):** The second edition was organized at the prestigious Karnataka Badminton Association on 24th September. The complete event was Digitalized and completely paperless from Registration, Auction to Scoring. Members from age 16 years till 65 years participated in JBL with 8 teams.

Teams were made through auctions process and were relayed online on youtube and 147 players participated in the Auctions. The finalist were Rajath Jewellers and Aparna Jewellers and the winners were Aparna Jewellers. Extremely innovative match points were designed to make sure every match is competitive and everyone gets an opportunity.

**Jewellers Cricket League (JCL 4.0):** JCL 4.0 (Jewellers Cricket League) which was already popular amongst all members which had a very positive response. We had 120 players Registration and 8 teams. The entire process was digitalized. As always there was a lot of Enthusiasm for the tournament. The tournament concluded on 8th October 2023 at YMCA, Nrupatunga road. The whole event was live on YouTube and very professionally conducted like an IPL event.

## B2B Shows:

**Silver Show of India (SSI) @ Mumbai** from 8th to 11th June: This was the second edition of SSI and the first one in Mumbai. It was organized at the JIO world centre under the auspices of IBJA and JAB. There were 448 stalls and 192 participants with a record 11500 visiting Jewellers.

**South jewellery Show (SJS) 5th edition** was held at Tripura Vasani Palace grounds from 1st to 3rd of September. There were 360 stalls and 132 participants with 6000 visiting Jewellers.

**Women's Wing:** An informative seminar was held on jewellery and women Empowerment by Guest speaker Ms. Mani Singhdeo on 26th March @FKCCI which was also a Networking event. The event saw many number of women Jewellers participating they were happy to learn more and exchange ideas with fellow women jewellers.

**Bengaluru Gold Festival 2 (BGF2):** The 2nd Bengaluru Gold Festival, meticulously organized by The Jewellers Association, unfolded as a grand celebration, weaving together the threads of Bengaluru's illustrious history in gold craftsmanship.

Set against the backdrop of the "Garden City" and "Health City" the festival aimed to elevate Bengaluru to the status of the "Golden City" The entire festival was seamlessly managed through digital platforms, From the issuance of coupons to the execution of weekly and bumper draws, the organizers prioritized transparency..

This event served as a culmination of a triumphant festival series that artfully showcased Bengaluru's legacy in gold craftsmanship and manufacturing. Notably, it played a pivotal role in promoting nakas and temple jewellery, cementing Bengaluru's position as a manufacturing hub for these exquisite pieces.

A diverse array of 147 participants, including corporate entities, chain stores, and standalone boutiques, participated wholeheartedly, underscoring their confidence in The Jewellers Association, Bengaluru's initiative to promote retail trade and reignite consumer preferences in the sector.

With a total of 3 kg of gold awarded to 330 customers and an impressive 64 kg of silver bestowed upon 514 customers. The cumulative value of these prizes amounted to an impressive Rs 2.15 crores.. As the curtains fall



on this successful edition, it sets the stage for an eagerly anticipated 3rd edition in 2024, promising to be grander and more captivating, further solidifying Bengaluru's status.

**Bye law change:** We tried to conduct an EGM to make the working of the association more transparent and also create more space to allow members to participate in the work of the association. However due to certain issue it could not be held. However the current board feels that the points raised will definitely make the association more transparent, improve working and provide a good platform for the future.

**JAB Monsoon Shelter:** Was completed in the Vanachchal at Kodagu and handed over to the village committee in March 2023. It is a 1500 sft community hall with two toilets. Total project cost 20.16 lakhs. Collected funds and accrued interest 18.2 lakhs. JAB contribution 3.4 lakhs

**Vidhya Jyothi Scholarship program** was planned from the excess funds from the BGF 1st edition. Scholarship was provided to 155 deserving kids of the karigars amounting to 7.75 lakhs.

**Sampark Abhiyan:** Many directors went and meet many of the members and talked to them to understand what the association can do to help improve their service.

**Jewellery Park:** The state administration changed and new administration have different priorities. However the committee members met the ministers of the new administration and updated them regarding the advantages of the project and requested them to reconsider the same.

#### Legal Issue

1. We have lost our appeal pending with the Commissioner in 3 out of five Income Tax cases. The board has moved ITAT on the matter.
2. There has been no hearing on the BIS hallmarking writ in the high court till date.
3. There is no progress on the chickpet property eviction case since the last AGM.
4. We had represented to the election commission regarding the movement of gold and jewelry during the election and found a workable solution for it. The Election commission has informed that such movement should be pre notified to it by means and an email. This was communicated to the members and it eased the movement of goods during the period.
5. The rules under PMLA were notified for our sector. We had discussions with the legal experts regarding it. Its clear that the jewellers who have significant cash receipts will have to follow the rules and if required register with FIU if their turnover is above a certain threshold. Other jewellers whose turnover is below the threshold need to register with the nodal officer of the association. The nodal officer of the Association will be channel that will provide the required reports to the FIU on behalf of the members as prescribed. Also its important that members take steps to KYC (Know your counterparty) and also due diligence as prescribed under the various rules prescribed. In this regard the association needs to restart the KYC of its members so it can provide the service as prescribed under the law.
6. Under PMLA there are few areas which need more clarity, the association needs to continue working with the legal experts and other associations.

# The Proceedings of the 48th Annual General Body Meeting of The Jewellers' Association held at Hotel Taj M.G. Road, M.G. Road, Bengaluru on 19th February 2023.

An invocation dance was performed to invoke the blessings of Lord Ganesha. Followed by which the lighting of the lamp was performed by the dignitaries.

**The meeting was called to order at 11:30 by the President, Mr. Prashant Mehta.**

The President in his address mentioned briefly about the events that took place in his short tenure of 10 months. He mentioned that on the issue of the Jewellery park the government was not able to give the land near the airport due to revenue constraints. However the government has asked its officers to look at other lands for which we are coordinating with the officials. One of the options is that we could take the land at a concessional rate from the government and it's something that we should consider. A new premise was taken for the Association office and we have already moved into the new office. The new website has launched with more useful data. Other than the exhibitions and Gyanjyoti programs, we successfully conducted the first Bangalore Gold Festival. We launched the women wing. Looking at the various work, GJEPC has honoured the JAB's President as one of the "Pillars of the Industry". With the profit made in the BGF, shows we wanted to contribute to our karigars and have started the VidyaJoythi scholarship program. Also C.KrishnaChetty has also planned to give funds to this initiative.

The Hon. Secretary covered the activities that were undertaken. He mentioned that there was a need in the market to have a good melting facility and the MC has taken the initiative to start a melting facility which is controlled by JAB. Also during the year we tried to work with various associations in the South to have one gold rate. This program worked for sometime, but due to the non cooperation the divergence between the rates across South India has reduced. The secretary assured that the MC will call a meeting on how we can get a more uniform rate across South India. However one of the members suggested that if we insist on uniform we can get into the wrong side of law with the MRTP act and should act cautiously. An update was given on the legal issues and issues considered that would make the business easier, these were w.r.t to samples taken by BIS, clarity on the interception rules under GST. Mr.Ramchandra has agreed to lead the issue related to Chickpet property eviction. He also said that it's not possible for everyone to know everything and hence it's better to make the Sub committee for the same. The wholesale trade is still facing an issue of not getting good quality refined gold. Few ideas that were suggested, (1) All gold (refined and impure) should be tested by fire assay only, XRF should be just for estimation. (2) JAB has empanelled a few BIS hallmarking centres to test gold. Since the BIS centres are standardised and controlled by BIS the variation in testing between two labs will be smaller and remove misunderstanding in the trade.

Mr. D.V. Ramesh. Chairperson of Bangalore Gold Festival (BGF) took the stage to present the details of it. BGF was an initiative to develop the retail trade, since it's the engine that drives the trade. The Dubai Shopping Festival and Lucky Laxmi were the inspiration for the festival. We branded it as BGF since we wanted to make Bangalore the city for gold, especially with the kind of jewellery being manufactured here and also retailers present here. A full blueprint was created with the legal, financials and other details. We had a legal adviser involved right from the start to ensure there is legal lacuna. We involved Art of Jewelry (AOJ) for sales and media plans. We involved GES India, to work on the logistics of the festival such as distribution of Arches, danglers, coupons, draws,... etc. SD Surana and Mr. Prasad were the legal advisors for the festival . A meeting was called with prospective

participants and the final plan was refined. We had a media plan where an advertisement was released every day in the newspapers, radio and also Television.

### **The brief highlight of the BGF are**

- 127 participants, with 10 Retail chain stores
- Gross Participation fee with GST collected Rs. 4,55,64,520
- Full page advertisement 15, Half page advertisement 16
- 1830 TV spots each for 10 seconds
- 1110 radio spots in radio for 10 seconds
- 3.83 lac impression on social media and 83K engagement on social media.
- Total Coupons printed 35.25 lakhs
- 21.33 Lakh coupons distributed initially, 8.33 lac additional coupons distributed
- Total 1900 prizes worth 1.51 cr announced, with include 2.5kg gold and 39 kg of Silver
- Unaudited surplus is about Rs, 40 lac
- Unused coupons were destroyed after the end of the festival, to avoid misuse by any person.
- All coupons were destroyed after the final draw as it contained sensitive information of the customers of the participant. This was a necessary condition under which all the participants agreed to take part.

All the prizes distributed till date have been audited by the auditor against the process set. The remaining prizes are taken back at the JAB office.

### **There were few queries / issues regarding the BGF which were clarified.**

1. One of the issues was the benefit was selective to only large players.
  - a. It had been clarified from data of web searches at goldfestival.in there were nearly 85,000 searches regarding the jewellers that participated. Hence it's clear that this did create interest and jewellers that did participate got additional business compared to jewellers that did not. Also with 3.83 lac impressions on the Social media there was a buzz created which was the objective of the festival. This might have also diverted certain disposable income from lifestyle, electronic and other goods into our sector meeting the objective for the festival. Hence the overall market should have increased giving benefits to various members. With these facts the issue was put to rest. Also there was advice by the board that as a fraternity we needed to work out our social media strategy together to promote our products. Further on social media the physical size of jewellers doesn't matter, what matters is visibility on social media. This can help the small stores compete with large format stores.
  - b. Also it was clarified that in order to ensure that the benefit reaches the smallest jewellers, there was a Rs. 50,000 category created to enable even a small store to take part in it.
2. A query was raised as to why Trilokesh Exports space was used. In this regard it was clarified that there was a logistical problem in doing the work from the association office, as vehicle movement was a challenge in the city area and also there was no lift to move the material or sufficient free space in the office to store the same. We were fortunate that Trilokesh Exports allowed us to use its office to run the festival, as there was sufficient parking, easy access, and a place to store the

material on the ground floor. Also they created space to help store the material and also distribute the prizes, which was convenient for the winners. Further this entire process was under the supervision of a senior board member(s).

3. Treatment of unsold coupons: It was clarified that there were 5.8 lac coupons were not distributed by the end of the festival. There could have been a chance that these coupons could make their way to the draw. Hence in order to avoid any such shortcoming it was decided to destroy the same at the earliest after the end of the final day of the festival. This decision was a routine decision for such programs. Also a legal opinion was sought for the same. In the same breath it was clarified that these unsold coupons had zero value after the end of the festival and not the face value as mentioned by some members, hence it was sufficient to take the decision at sub committee level.
4. There was a query regarding a case where there were sequential sets of coupons in a draw. The chair clarified that this was in the first draw. During this time we had a chief guest and requested him to pick 10 coupons. Unfortunately he picked a bunch from a single location, which gave rise to the issue. In later draws the process was streamlined and they had to pick each individual coupon from a different location in the box.

There were allegations against prominent members that they sold the undistributed coupons in the market for cash and there was a cover up done. Other allegations were major errors in the prize list, special treatment given to a particular jeweller, burning of coupons was without proper authority all the statements were made without any proof, subjective, based on hearsay and or proper notice. Hence such details are not recorded since it unnecessarily harms the reputation of prominent members and also of the association. These sensational statements stirred a pandemonium in the AGM. In the pandemonium few members tried to pronounce a voice resolution for resignation of a few members which was not on the agenda, no permission was sought from the chair or any process of natural justice followed such as proper notice, proof, counter or discussions. For the voice resolution there was no show of hands to get the feel of the General body on the issue. Further the resolution has no legal sanctity as no due process was followed and hence details are not recorded. Also there are few unnecessary points raised on working of the board and process, targeting few individuals which are not to be recorded for reasons already stated above.

It was clarified by senior member Mr.Ramchandra that it was not right to unnecessarily ask such resignations as it would send a wrong signal in the market given the excellent work done. Mr. Sanjay of M.P. Jewels said that there could have been some shortcomings but nothing intentional and there is always room for improvement. Members were asked not to create ruckus or stall the proceeding.

Most in the general body were appreciative of the work done on BGF, trade shows and the ladies wing. It had so happened that for the first time one of the ladies wanted to become director of the board. The AGM requested that it be looked into and the chair promised to do whatever was possible in this regard.

Vivek B Chand congratulated the whole Board on the huge profit this year. He proposed withdrawal / loosing contestants should not be considered as Co-opted directors. Next year the looser / withdrawal contestants can contest in the election. We knew there was a lot of Horse trading / politics happening. Ketan S Dhruv informed that, it's a good suggestion, there is an EGM shortly, we would take up in the EGM. Few members requested the Committee to consider all past presidents, senior members of the industry for bye-law amendments in EGM. This was agreed by the chair as well.

Prashant Mehta thanked august general body & thanked G.V. Sreedhar, Ramachandra, Mahendra and other for their wise words to help solve the issue. He requested Urish Chhajed and Hardik to start the election process.

Urish Chhajed briefed about the Election module to the general body. The proposed names are observers in the Election. The observers selected were Sandeep Saparam, AkshayGadiya, M.S. Venkatesh.

All the contestants requested the general body to cast their votes on their behalf.

The board has decided to donate Rs. 5 lac to the new program "VidyaJyothi", which is a scholarship program for the students of our Kargiars. Also Mr.VinodHigrav of C.KrishnaihChetty has provided Rs. 5 lac for the program.

Mr.Premchand from D.P. Gold asked the committee to look into the issue of police harassment.

G.V. Sreedhar asked the Treasurer for his justification for taking the approval on 25 lacs for office renovations & interiors. AGM would allow only 5 lacs.

R.V. Tushar has briefed about the expenses incurred for new office renovations & approximate expenses amount was Rs. 28 Lacs plus.

G.V. Sreedhar – How can you spend 28 Lacs when the General body approved only 10 Lacs. You must take the permission / approval by the AGM not the intimation given to AGM.

B. R. Ramachandra asked to remit back to the Association account the excess expenditure of 10 plus lacs.

Prashant Mehta – We wanted to renovate within the 10 Lacs, but, we didn't get the proper premises with in the budget. The new office of jab is approximately 1500 sfts& renovated in Corporate style with all secured accessories. We should also pay the rental charges monthly, it was also a burden for us. Hence, we have completed the work with the confidence that the general august body would permit. Prashant Mehta informed that, R.V. Tushar, Director is a builder on his work experience he has completed the office renovation work. Also he specified that the amount has not been spent but converted to assets and this needs to be treated differently.

G.V. Sreedhar – He asked why the staff salaries budget is more in the estimated budget 2023-24?

Prashant Mehta informed that, staff are getting 10% or 15% hike in salary on every year under supervision of N Vidya Sagar & planning to appoint new staff.

Regarding Rental charges: The board was planning to convert the old office for melting / refinery or assaying purposes, since we were getting many complaints from the members regarding melting defects in the refineries in the bazaar. N. Vidya Sagar showed interest to open the melting centre

associated with JAB & has submitted the letter & also he shares the rental charges of the old office. We try to negotiate with a few refineries, if not we surrender the old office.

Ajit Kumar – Have you taken the permission to shift the office from old premises to new premises? Why are you paying Rs. 45,000 per month as rental charges. It was informed that there was an eviction notice for the old office and if no action was taken, we could be without a premise.

R. Srinivas informed that, 2022-23 estimated budget had already taken the approval in the last AGM. Pls consider the approved budget. We request for the 2023-24 budget to be approved by AGM.

Ketan S Dhruv informed that, we have 4 cases at Court

- 1.BIS Writ in High Court
- 2.Eviction of Chickpet Tenant
- 3.Legal representation to GST.
4. The Income tax cases.

Also for making effective presentations to the department we need to take help of legal experts such as LaxmiKumaran and Sridhran or similar.




